The Inquiry wishes to hear from any members of the public, emergency responders and others who were present at the Arena on 22 May 2017 and who have information which may help its investigation into the bombing. The Inquiry particularly wishes to hear from anyone who was present in the City Room before the explosion or who was present at / around the Arena or Manchester Victoria Station after the explosion and witnessed the emergency response.

This is an important form. We hope that anyone who wishes to provide information to the Inquiry will complete it. We are not asking you to provide a written statement now but rather to let us know if you have information which may be helpful to the Inquiry. Please provide as much information on this form as you are able to give.

Any information that is provided will be carefully reviewed by the Inquiry. You may be asked to give further details about the information on this form and to provide a witness statement to help the Inquiry. A witness statement is a formal document that may be used by the Inquiry during its hearings and disclosed to the parties involved in the Inquiry, known as Core Participants.

The information provided on this form will be held confidentially by the Inquiry on the basis that any relevant information can be confirmed formally in a witness statement. If it is not possible to obtain a witness statement to confirm the details you have provided, the information provided in section 2 of this form ('summary of your evidence') and your name may be disclosed to Core Participants. Any personal data or medical information would be redacted, i.e. removed, before the form is disclosed.
