

**Call from NWFC to Andy Berry****22<sup>nd</sup> May 2017 22:40hrs**

- NWFC (22.40.00):** ...Andy.
- Andy Berry (22.40.02):** Hiya control.
- NWFC (22.40.02):** Hello Andy, it's Michelle. Duty Team Leader.
- Andy Berry (22.40.06):** Hiya you ok?
- NWFC (22.40.07):** Hi, um... You're Duty NILO this evening, aren't you?
- Andy Berry (22.40.09):** I am.
- NWFC (22.40.10):** Ok, so we are receiving reports of an explosion at the Manchester Evening News arena.
- Andy Berry (22.40.16):** Ok.
- NWFC (22.40.17):** Um... there has been a... so it's already detonated. Erm... The police that we've got on the line are saying it is a bomb.
- Andy Berry (22.40.22):** Ok.
- NWFC (22.40.28):** Um... explosion in the foyer area of the Manchester Arena where McDonalds used to be. Er... It's the merchandise stand.
- Andy Berry (22.40.36):** Ok.
- NWFC (22.40.38):** There has been 30 casualties reported so far.
- Andy Berry (22.40.42):** Yeah.
- NWFC (22.40.44):** Er... the rendezvous point at the moment is the car park area outside the cathedral.
- Andy Berry (22.40.50):** The cathedral. Ok.
- NWFC (22.40.52):** Yep. Erm... You will have to bear with me cos we're literally... I'm... I've just phoned you while we are still on to the police. Would it be alright for you to get in touch with them, er... obviously we are not mobilising at the moment. Erm...
- Andy Berry (22.41.04):** Yep.
- NWFC (22.41.04):** So, can you just speak to them and we'll hang fire?
- Andy Berry (22.41.08):** Ok, so... what we restricting movements or what we got a rendezvous point for the fire engines in the area?
- NWFC (22.41.17):** Is, is the, is the car park area outside the cathedral.

**Andy Berry (22.41.20):** Right, but we would normally muster them at one of the stations wouldn't we?

**NWFC (22.41.25):** Right, ok. Just bear with me then one second. Erm..

**Andy Berry (22.41.31):** So we could do that first, we could get four pumps at one of the stations... Erm... probably not that close, so we wouldn't want Central...

**NWFC (22.41.40):** So we want a muster point?

**Andy Berry (22.41.43):** Yea so we...

**NWFC (22.41.43):** Ok.

**Andy Berry (22.41.46):** We want to go for... we might go for Philips Park or somewhere like that.

**NWFC (22.41.46):** Philips Park or somewhere like that? Ok.

**Andy Berry (22.41.48):** Yeah.

**NWFC (22.41.48):** Ok.

**Andy Berry (22.41.51):** Well we will do. We'll go for Philips Park.

**NWFC (22.41.52):** Philips Park? Right ok, we can create an incident then and erm...

**Andy Berry (22.41.57):** Yep.

**NWFC (22.41.58):** We've just got a member of the public on the phone as well that is erm... involved in the incident. We're just getting some more information in, but I don't know if you want that at the moment?

**Andy Berry (22.42.07):** No, just give me four pumps to standby or rendezvous at Philips Park for now. I'll speak to the Force Duty Officer.

**NWFC (22.42.15):** Yep, no problem at all. We'll do that Andy and we'll speak to you shortly.

**Andy Berry (22.42.18):** Ok.

**NWFC (22.42.20):** Alright, thank you very much.
